

Firefly Completes Acquisition of the Yalgoo Gold Project

Firefly Resources Ltd (**ASX: FFR; Firefly or the Company**) is pleased to announce that, with all resolutions having been passed at the General Meeting held on 30 July 2020, it has now completed the acquisition of the Yalgoo Gold Project in WA from privately-owned Aurum Minerals Pty Ltd following the issue of the consideration securities. All conditions precedent to the transaction have also now either been satisfied or waived.

An Appendix 2A is attached for the 97,000,000 Consideration Shares and 22,999,998 Performance Rights. The Consideration Shares will rank equally with existing fully paid ordinary shares.

Firefly Managing Director Simon Lawson said: *"Our shareholders have overwhelmingly endorsed this acquisition and our growth strategy in the WA gold sector by supporting this transaction at yesterday's General Meeting. With the acquisition now finalised, we are looking forward to getting on the ground and getting on with the job of drilling and exploring to establish a JORC 2012 Mineral Resource and make new discoveries at the Yalgoo Gold Project."*
